## Guardian

## Business Start-Up (continued)

If any of the forenamed Business Advisors is unable or unwilling to make such a determination, the Business Advisors shall make such determination so long as there is a minimum of three (3) individuals involved. If any of the Business Advisors is unable or unwilling to make such a determination, such Business Advisor may appoint a successor individual to serve in his place; the remaining Business Advisors shall unanimously appoint a successor individual to serve with them as Business Advisor.

The individuals appointed to serve as Business Advisors shall in no way be responsible or liable for actual performance of profitability of my child(ren)'s proposed business venture.

## Counseling

☐ **Grief Counseling:** Due to the impressionable age of my children, I caution my Trustee(s) and Guardian to be vigilant in observing signs of distress or difficulty in coping with the situation after my death.
