OFFICIAL RULES

Participation in the Christmas Stories Podcast Giveaway 2025 (the “Sweepstakes”) is contingent on your full and unconditional agreement to and acceptance of these Official Rules. The Sweepstakes is sponsored by Focus on the Family, 8605 Explorer Drive, Colorado Springs, CO 80920 ("Sponsor").

1. NO PURCHASE NECESSARY TO ENTER.

2. Sweepstakes. The Sweepstakes will be held between November 21 and December 31, 2025, inclusive (the "Sweepstakes Period"). Entries must be received during the Sweepstakes Period. Time of entry is Mountain Time.

3. How to Enter. To enter the Sweepstakes: Go to the entry page at <https://www.focusonthefamily.com/christmas-stories-podcast-resources> and complete all the required fields. Upon completing and submitting the form, you will have entered the Sweepstakes.

4. Agreement to Official Terms and Conditions. By participating in the Sweepstakes, entrants agree to abide by these Official Rules. Any entrant or winner who violates these Official Rules is subject to disqualification at any time at Sponsor’s sole discretion.

5. Eligibility. Participation is open only to individuals 18 or older who are legal residents of the fifty United States and its territories and possessions, and the District of Columbia. Entrants are subject to all federal, state and local laws, rules and regulations. Void outside of the 50 United States, its territories and possessions, and the District of Columbia, and where prohibited, taxed or restricted by law. Employees, officers and directors of Sponsor and its affiliates, partners, advertising and promotion agencies, any agencies involved with administering the Sweepstakes, manufacturers or distributors of Sweepstakes materials and prizes, and their immediate families (parents, children, siblings, spouse) or members of the same household (whether related or not) of such employees/officers/directors are not eligible to enter. Limit one entry per person.

6. Prize; Random Drawing/Odds. One (1) winner will be selected by Sponsor in a random drawing after the conclusion of the Sweepstakes Period, from among all valid entries received during the Sweepstakes Period. The winner will receive a signed print by artist Morgan Weistling titled *The Prodigal*. The odds of winning depend on the number of eligible entries timely received. Sponsor is responsible for determining the winner of the Prize in its sole discretion, subject to these Official Rules. All decisions made by Sponsor concerning the award of the Prize shall be final and binding.

7. Consumer Disclosure of Prize. The Prize is valued at approximately \$300.

8. Prize Delivery. Sponsor will ship the Prize at Sponsor's expense, at a mailing address provided by the winner. All other expenses incurred by the winner in conjunction with the Prize will be the responsibility of the winner. Prize may not be assigned, transferred, changed, or redeemed for cash, except at Sponsor's sole discretion.

9. Notification. Winner notifications will be made within fifteen (15) days of selection. In the event of noncompliance with these Sweepstakes rules and requirements, such Prize will be forfeited and an alternate winner may be selected from all remaining eligible entries. Upon Prize forfeiture, no compensation will be given.

10. Conditions. All federal, state and local taxes are the sole responsibility of the winner. Participation in Sweepstakes and acceptance of Prize constitutes the winner's permission for Sponsor to use winner's name, address (city and state), and any statements made by a winner regarding the Sweepstakes or Sponsor for advertising and promotional purposes without notice or additional compensation, except where prohibited by law.

Entrants who are found to have submitted multiple or bulk entries in connection with the Sweepstakes shall be disqualified. No automated entry devices and/or programs permitted. 11. Additional Terms. In case of dispute as to the identity of any entrant, entry will be declared made by the authorized account holder of the email address submitted at time of entry. "Authorized Account Holder" is defined as the natural person who is assigned an email address by an Internet access provider, online service provider, or other organization (e.g., business, educational, institution, etc.) responsible for assigning email addresses or the domain associated with the submitted email address. Any potential winner may be requested to provide Sponsor with proof that such winner is the Authorized Account Holder of the email address associated with the winning entry. Any other attempted form of entry is prohibited; no automatic, programmed; robotic or similar means of entry are permitted. The Sweepstakes Entities are not responsible for technical, hardware, software, telephone or other communications malfunctions, errors or failures of any kind, lost or unavailable network connections, web site, Internet, or ISP availability, unauthorized human intervention, traffic congestion, incomplete or inaccurate capture of entry information (regardless of cause) or failed, incomplete, garbled, jumbled or delayed computer transmissions which may limit one's ability to enter the Sweepstakes, including any injury or damage to participant's or any other person's computer relating to or resulting from participating in this Sweepstakes or downloading any materials in this Sweepstakes. In such case, Sponsor may select the winner from all eligible entries received prior to and/or after (if appropriate) the action taken by Sponsor. Sponsor

reserves the right, at its sole discretion, to disqualify any individual it finds, in its sole discretion, to be tampering with the entry process or the operation of the Sweepstakes or web site. Sponsor may prohibit an entrant from participating in the Sweepstakes or winning a Prize if, in its sole discretion, it determines that said entrant is attempting to undermine the legitimate operation of the Sweepstakes by cheating, hacking, deception, or other unfair playing practices (including the use of automated quick entry programs) or intending to annoy, abuse, threaten or harass any other entrants or Sponsor representatives.

The parties agree not to raise the defense of forum non conveniens.
