1. NO PURCHASE NECESSARY TO ENTER.

- **2. Sweepstakes.** The Sweepstakes will be held between November 21 and December 31, 2025, inclusive (the "Sweepstakes Period"). Entries must be received during the Sweepstakes Period. Time of entry is Mountain Time.
